## Joint Short Staff Training Event (JSSTE) - Nicosia, Cyprus

Partner teams of TNP project met at the planned JSSTE in Larnaca, 03-09, June 2018. Sunday, 03, was determined as a day for arriving and accommodating of partners in the city of Larnaca. On Monday, 04, the partners moved by bus to European University of Cyprus (EUC) in the capital Nicosia. Project participants worked together according to the schedule of JSSTE (summary of outputs and the tasks for next days). Cyprus team presented output 01 – General and Health parts EDO/Tempate. After lunch partner teams worked on the output 02 – Study report (text files and worksheets), Cyprus team presented the Questionaire for validation. The evening programme included dinner connected with a cultural event – Greek dance performance in Leivadeia village, Larnaca.

On Tuesday all participants went by bus to visit Larnaca Hospital/Thallasemia and then to see Halla Sultan Tekke and St Lazarus Church. The afternoon programme was dedicated to the visit of Primary Care and Mental Health Services and city sightseeing by walk.







During Wednesday's morning programme the partners transferred again to EUC, Nicosia, and they spent working time on output 03 – Brochures; after lunch they were dealing with the output 02 – Video recordings. The joint dinner was organized in the traditional restaurant (at a Medieval Castle).



On Thursday in the morning the participants went by bus to Kolossi Castle, Limassol and Kourion Archeological Site located on the Cypriot coast. They visited the old harbor in Limassol, ruins of greek Kourion, original amphitheatre and excavations. The sightseeing tour was finished with a visit of Lefkara traditional village.







On Friday, a last meeting day, project teams were working on outputs of 04 (Dictionary) between 9 and 12 am. After lunch the partners discussed tasks for next meeting, they evaluated meeting tasks and they received the certificates of paticipation. The partners returned home on Saturday.







The participants of a project meeting arrived on Saturday, 9 June. Sunday meeting was held in EUC, Nicosia. The morning programme was focused on financial matters and dissemination plan joint session. Each partner presented the strategy of dissemination, the verification strategy of output 2. The Czech partners set conditions for next meeting in Turkey. All partners signed the autorship agreement. In the afternoon the separate meetings of the partner teams took place according to the schedule. The partners were informed about the preparation of a joint document on the protection of personal data under EU legislation (GDPR). The document will be placed on the project website.

On Monday the participants visited Nicosia General Hospital. After the excursion the partners jointly solved the student mobility conditions and evaluated the period from the last meeting. On Tuesday the project partners left Cyprus.



Next meeting is scheduled to take place in Izmir/Turkey, in autumn 2018.
